Applicability: This Form and Notice is applicable to each current or prospective customer, account holder, borrower, guarantor or surety or person furnishing any security for a customer, account holder or borrower (collectively "client") of Hong Leong Finance Limited (the "Company") who have or are proposing to enter into any of the following arrangements with the Company:

Purpose: On and from 2 July 2014, this Form and Notice describes how personal data (as defined in the PDPA) of or relating to clients may be collected, used and disclosed by the Company.

Personal data which may be relevant: The Company may request or require a client to supply personal data, including personal data of the guarantors, legal or beneficial owners, family members, managers or directors (if and as relevant) of the client, for example information about whether any immediate family members has/have been entrusted with prominent public functions, or whether the client has been served with any statutory demand under the Bankruptcy Act. If the client refuses or is unable to provide such personal data for use and disclosure by the Company as described in this Form and Notice, or if subsequently any action taken results in the Company ceasing to be entitled to collect, use or disclose such personal data as described in this Form and Notice, the Company may not be able to open or maintain accounts or begin or continue to provide a Product (or part thereof) or other facilities or services to that client. will seek to inform any such affected client prior to taken any relevant action.

- Expectation and undertaking in respect of third party personal data: If a client is requested or required to supply such personal data to the Company, or actually provides such personal data to the Company, the Company expects the client to have informed each individual whose personal data is supplied or provided to the Company that the Company may use their personal data for one or more of the purposes described in this Form and Notice.
